Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Absorption, Distribution and Excretion

Part of the intravenously admin antimony salts are absorbed by erythrocytes, and the rest is distributed to other tissues, predominantly the liver, adrenals, spleen, and thyroid. In rats, trivalent antimony is absorbed by erythrocytes, distributed to other tissues, and retained in the liver for a short time before it is gradually excreted in feces; pentavalent antimony remains in the plasma for a short time, and most of it is excreted in the urine, while a part is retained in the hair. In the livers of mice and humans, pentavalent antimony is reduced to the trivalent form. Antimony salts

spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
