SECTION 5: Firefighting measures**Suitable extinguishing media**

Use dry chemical, carbon dioxide or alcohol-resistant foam.

Not combustible but enhances combustion of other substances. Gives off irritating or toxic fumes (or gases) in a fire. Risk of fire and explosion on contact with combustible substances or reducing agents.

Special protective actions for fire-fighters

Use water in large amounts.

SECTION 6: Accidental release measures**Personal precautions, protective equipment and emergency procedures**

Personal protection: particulate filter respirator adapted to the airborne concentration of the substance. Do NOT absorb in sawdust or other combustible absorbents. Sweep spilled substance into covered sealable containers. If appropriate, moisten first to prevent dusting. Carefully collect remainder. Then store and dispose of according to local regulations.

Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use

spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
