Description of necessary first-aid measures

If inhaled

A pKa of 9.58(1) indicates levorphanol will exist almost entirely in the cation form at pH values of 5 to 9 and, therefore,

bioconcentration in fish is not expected to be an important fate process(SRC).

Mobility in soil

The Koc of levorphanol is estimated as 560(SRC), using a log Kow of 3.11(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that levorphanol is expected to have low mobility in soil. The pKa of levorphanol is 9.58(4), indicating that this compound will exist almost entirely in the cation form in the environment and cations generally adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(5).

Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
